Full details of the resolution to be proposed at the General Meeting, with explanatory notes, are set out in the shareholder circular made available to members of the Company ("UKCM Shareholders") on 9 April 2024 (the "Scheme Document"). Unless otherwise defined, all capitalised words and phrases in this Form of Proxy and these Explanatory Notes shall have the meanings given to them in the Scheme Document.
- 2. Pursuant to Regulation 41 of the Uncertificated Securities (Guernsey) Regulations 2009, entitlement to attend, speak and vote at the General Meeting and the number of votes which may be cast thereat will be determined by reference to the register of members of the Company (the "Register of Members") at 6.00 p.m. on 30 April 2024 (or, if the General Meeting is adjourned or postponed, at 6.00 p.m. on the date which is two non-Business Days prior to the date set for the adjourned or postponed meeting). If someone else signs your Form of Proxy on your behalf, the power of attorney or other authority under which it is signed (or a notarially certified copy of such power of attorney or authority), must accompany the Form of Proxy.
